To verify the energy usage and GHG emissions only for Dixons Carphone Plc (a quoted company) against the requirements of Streamlined Energy and Carbon Reporting for the financial reporting period of 01 May 2020 – 30 April 2021. The verification was conducted to a limited level of assurance.

Scope and Methodology

The verification covers Scope 1 and Scope 2 emissions in the UK and Ireland, Greece, Denmark, Finland, Norway, Sweden under the operational management control of Dixons Carphone Plc. Data and calculations selected for verification were based upon a risk assessment approach. The verification also included completeness checks. Emission factors were based on best available information where possible and were taken from UK Government GHG Conversion Factors for Company Reporting 2020 and Association of Issuing Bodies Factors. Scope 3 emissions are not reported nor verified except company mileage in private vehicles which is included under 'emissions from combustion of fuel'.

Verifiers Opinion

Based on the evidence provided and the samples selected for verification, it is the opinion that the information required by the Companies Act 2006 (Strategic Report and Directors' Report) Regulations 2013 ('the 2013 Regulations') and the Companies (Directors' Report) and Limited Liability Partnerships (Energy and Carbon Report) Regulations 2018 ('the SECR Regulations'), as contained in the Dixons Carphone Plc Director's Report, covering the financial reporting period of 1st May 2020 – 30th April 2021 is materially correct based on the scope presented and is a fair representation of the GHG data and information and was compiled in conformance with the verification criteria described above. The data and information supporting the GHG assertion were historical in nature.
